

Proposal Number 2, a Question: CIVILIAN COMPLAINT REVIEW BOARD – Citywide

This proposal would amend the City Charter to: Increase the size of the Civilian Complaint Review Board (CCRB) from 13 to 15 members by adding one member appointed by the Public Advocate and adding one member jointly appointed by the Mayor and Speaker of the Council who would serve as chair, and to provide that the Council directly appoint its CCRB members rather than designate them for the Mayor's consideration and appointment;

Require that the CCRB's annual personnel budget be high enough to fund a CCRB employee headcount equal to 0.65% of the Police Department's uniformed officer headcount, unless the Mayor makes a written determination that fiscal necessity requires a lower budget amount;

Require that the Police Commissioner provide the CCRB with a written expla-

This proposal would amend the City nation when the Police Commissioner intends to depart or has departed from discipline recommended by the CCRB or by the Public Advocate Deputy) Commissioner for Trials;

Allow the CCRB to investigate the truthfulness of any material statement that is made within the course of the CCRB's investigation or resolution of a complaint by a police officer who is the subject of that complaint, and recommend discipline against the police officer where appropriate:

Allow the CCRB members, by a majority vote, to delegate the board's power to issue and seek enforcement of subpoenas to compel the attendance of witnesses and the production of records for its investigations to the CCRB Executive Director.

Shall this proposal be adopted?

Black Homeowners Lobby Trump to Investigate Brooklyn Courts

More than 100 members of Gideon's Army for Black & Latino Homeowners came together this past weekend in front of Trump Tower (725 5th Avenue in Manhattan) to lobby the Trump Administration to look at the foreclosure crisis affecting Black and Brown homeowners in Brooklyn.

Specifically, the activists requested Trump and the federal government to launch a federal investigation of the New York State Court System. The courts in New York are foreclosing on Black and Latino homes at alarming rates through predatory lending, the Third-Party Transfer Program (TPT) and unjust rulings by foreclosure judges, the advocates said.

According to the U.S. Census, homeownership has decreased by 50% in communities of color. People familiar with the Kings County Court System say that hundreds of properties are auctioned off every month and thousands more are facing foreclosures.

"We are American citizens and our

rights are being violated. Our homes are being stolen and our families are being displaced by becoming a part of the statistic of 64,000 homeless in New York City. Enough is Enough. We are asking President Trump for help," said James Caldwell, one of the organizers of Gideon's Army and the President of the 77th Police Precinct Community Council.

The other driving forces behind the rally in front

of Trump Tower included Homeowner Advocacy Group President Karen Greenwood and Foreclosure Revolution Cooperative Society President Jawan Bey.

The groups charge that the unconscio-

nable fraudulent foreclosures continue to go on unabated even after the disclosures

> of the big banks, mortgage loan services and foreclosure- mill attorneys have been outed by the Congressional Financial Crisis Inquiry Commission Report of 2010.

> "As a result of that congressional report, there is literally no good reason for homeowners to be dispossessed of their homes when the government is fully aware of the fraudulent, unfair business practices that the financial industry

has wrought upon the American people. It is our collective opinion that President Trump should initiate a federal investigation of every state's judicial foreclosure docket because the judges of every state

have been enabling the fraud and violation of homeowners' rights without restriction or impartiality through court adjudications," Greenwood, Bey and Caldwell said in a joint statement.

Caldwell, Greenwood and Bey said they are committed to bringing attention to this issue. They are determined to compel the elected officials and those seeking elective office to make this issue a part of the coming election cycle. Candidates who are soliciting their membership's support or vote, must take an interest and uncompromising position on this.

"We feel there needs to be a federal investigation into the New York Court System regarding how the Black and Latino community are losing their homes and the unjust decisions by the local judges. We feel we are not getting enough help from our local politicians in standing up for the Black and Latino communities," said Caldwell.

The Central Brooklyn Food Coop is Off and Running

A new and Black-led food cooperative offering fresh produce, healthy grocery items and other nutritive fare will open next year, serving Bedford-Stuyvesant and Crown Heights. It's been a long time coming but judging from the jubilation of its organizers and the enthusiastic reception of area residents, it was worth the wait. And

people from outside the neighborhood are welcome as well (Some longtime Brooklyn residents will recall that, although the Central Brooklyn Food Coop is being reported in several news media outlets as the first Black-owned initiative of its kind, that's actually not the case. In the 1970s The East organization ran Kununuana, a food coop selling groceries and produce on Fulton Street at the corner of Claver Place).

The Coop has raised close to \$35,000 on Kickstarter, meeting its first step goal of \$25,000 in only six days. They plan to use those donations to rent a Fulton Street storefront. The campaign ends at midnight on November 22nd and if the \$100,000 target is reached, the organizers will be able to cover the expenses for renovating and outfitting their new place, complete with a kitchen for cooking classes and other offerings.

"Yes, the Coop is meant to have an impact on a particular community, but anyone from anywhere can join," said Mark Winston Griffith, founder and director of the Brooklyn Movement Center (BMC) and a founding member of the Central Brooklyn Food Coop (CBFC).

"The CBFC is one of the bedrock campaigns of the Brooklyn Movement Center," said Winston Griffith. "So this a huge shot in the arm!"

It takes a long time to get something so critical and comprehensive up and running. But Winston Griffith is a long longtime community activist and organizer with patience and perspective. He's learned the value of incremental steps; delays, setbacks and rethinking are to be expected and can serve the purpose of creating a tested and

Because the Coop is the brainchild and passion project of the BMC, Coop board members will be working along with it to rebuild an affordable and sustainable local food economy. But the Coop will also operate independently, with its work connected to the broader objectives of its communities and establishing beneficial and viable partnerships with like-minded sources and resources.

The CBFC is already benefitting from its existing collaborations working with RiseBoro Community Partnerships and Brooklyn Packers. Its buying club has supported local farmers and bakeries, etc. many of which are Black-owned businesses.

As gentrification continues in Bedford Stuyvesant and Crown Heights, many people whose families have been there for generations are not able to – or do not choose to – patronize the high-end supermarkets and twee coffeehouses. But their patronage is critical to those small business trying to remain in the black.

"We [at BMC] are a community organization trying to change policies and practices," said Winston Griffith, "but we can't do that without building an institution that delivers tangible benefits and meets people where they are in terms of their needs. In this case, we're literally going to feed them and put some money in their pockets."

Ina Solomon has been with the CBFC since 2014. She is now on the Board of Directors and co-chair of the Coop's Business and Strategy Committee. A longtime Park Slope Food Coop member, she was delighted when she first learned that a healthy food initiative such as the CBFC was coming to her neighborhood. And it will model itself on the PSFC, one of the largest

(with 17,000 members) and longest-running coops in the nation. It has remained successful as a member-only cooperative where everyone – with the exception of paid staff – works the same number of hours per month and low-income members get a break on initial fees and membership dues

Ina is dedicated and enthusiastic.

"The Business and Strategy committee provides the operational strategy for our work. Some of our projects include writing the business plan, organizing our property search, developing the financial models and projections. We have over 50 invested members in the coop, but our group of supporters is much larger. That number is a few hundred. We are aiming to have at least 500 invested members by the time the store opens in 2020."

She echoes Winston Griffith's conviction that the CBFC is in the right place at the right time and is poised to make a difference not only for – but with the community.

"We are a mission driven coop that aims to provide healthy food options for the long-term residents of Central Brooklyn," said Solomon. "We are approaching our work with a deep sense of responsibility, care and love for our community and that takes time. We want to get it right.

"From the beginning everyone I have spoked to is excited about the project. Folks are glad to see that we're still working towards making this happen and that we are even closer to opening the doors. The energy feels pretty good right now. We are at an exciting stage of our development!"

John Conyers, Jr., Co-Founder of the Congressional Black Caucus, Dies at 90



• By Katherine Lewin, diversityinc.com John Conyers, Jr., who co-founded the Congressional Black Caucus, helped create Martin Luther King, Jr. Day and be-

came the longest-serving Black person in Congress, died on Sunday at his home in Detroit, spokeswoman Holly Baird confirmed. He was 90.

Conyers' long political career as a Dem-

he was only one of five Black people in the House. Over the decades, he was reelected 26 times. He eventually became the "Dean of the House of Representatives" because when he finally resigned at 88 years old, he was the longest-serving member of the House.

"For the Congressional Black Caucus, Congressman Conyers was more than a founding member. He was a guiding light," the Congressional Black Caucus said in a statement Monday. "We will continue his vision by serving as the 'Conscience of the Congress' in pursuit of justice for all Americans. We extend our deepest condolences to his wife, sons, family and friends. A son of Detroit and champion of civil rights, Mr. Conyers lived a life dedicated to serving the community in which he was raised. He leaves a legacy of more than five decades of systematic change that continues to transform our country for the better to this day."

Conyers has had a hand in many of the most influential bills and political movements of his time — he co-sponsored the Voting Rights Act of 1965, was openly

ocrat from Michigan began in 1964 when against the Vietnam War and voted against the USA Patriot Act after 9/11, which rolled back civil liberties for all Americans, supposedly in the name of national security.

"In many districts around the country, Black voters did not feel represented by their leaders, so they would reach out to African-American congressmen like Con¬yers," Michael Fauntroy, a former intern for Convers in the early 1980s, told The Washington Post.

However, the longtime politician resigned in disgrace at 88 years old in 2017 after multiple allegations of sexual misconduct with his female staffers were reported. According to Buzzfeed News' reporting, several of the women who worked in his office claimed that he propositioned them for sex and touched them without their consent.

A wrongful dismissal complaint that started the inquiry into Convers said that a female staffer was fired because she would not have sex with the congressman. That eventually was settled for thousands of dollars. But when it hit the media, he faced calls to step down. He did but denied all of the allegations.

DNC on the Passing of Rep. John Conyers DNC Chair Tom Perez released the following statement:

"Congressman John Conyers was a civil rights warrior, a lifelong public servant and a stalwart Democrat. Over the course of his public service career, which spanned more than half a century, Rep. Conyers led groundbreaking fights that advanced the course of history, including introducing the first bill to establish the Reverend Dr. Martin Luther King, Jr. Holiday. As a co-founder of the Congressional Black Caucus, he changed the face of leadership in the halls of Congress and blazed a trail for future leaders of color. My heart goes out to the Conyers family as they mourn his passing and celebrate his life in public service."

posed the Vietnam War, the Persian Gulf War and the Iraq War. He opposed President Reagan's "constructive engagement" with apartheid South African leaders. After Dr. Martin Luther King's death, he was one of the early advocates of a King Birthday National Holiday. He was a co-founder of the Congressional Black Caucus which was created in 1971.

A critic of the death penalty, Conyers initiated hearings on police brutality and NYC Blacks during the mayoral watch of Ed Koch in 1983 and of Rudy Giuliani in 1997. He held the hearings in the Harlem State Office Building on 125th Street in Harlem and the media voraciously consumed the proceedings. He supported extensive federal benefits for police and firefighters who were killed on the job. He supported the censure of Congressman Adam Clayton Powell in 1967. Powell's decline signaled Conyers' ascension. Later that year, the Washington Post wrote that "he was emerging as the leading Negro voice in Congress and while there were 5 other Black congressmen, Conyers acted as though he has the constituency of 22

This law encourages the placement of youth in foster care with relatives instead of strangers by making a much-needed amendment to the Family Court Act. It expands the definition of people who are eligible to petition the court to become foster parents who are related to the child:

- Through blood, marriage or adoption
- Through a half-sibling of the child through blood, marriage or adoption and the person is or are the prospective or appointed relative guardian of the half-sibling; or
- By a positive relationship with the child including, but not limited to, a stepparent, godparent, neighbor or family friend.

"Already difficult circumstances become more challenging for children who placed with strangers. Whenever possible, we should try to support and strengthen existing family ties for young people caught up in the child welfare system," said State Senator Velmanette Montgomery. "I am happy the governor signed my bill so we can make it a little bit easier for caring relatives and those invested in the child's well-being to step in and assist in these times of need."

Assemblywoman Ellen Jaffee, Chair of the Assembly Committee on Children and Families said, "By expanding kinship care, we are providing more resources for those caring for foster children. This new law will keep siblings together by allowing relatives and any nonrelative with a positive relationship with the child to become permanent guardians. This will create a stable and healthy environment for foster children. Thank you to Governor Cuomo for recognizing the importance of foster families and their basic needs."

He served in the Korean War as a second lieutenant, returned to Detroit, completed his undergraduate studies at Wayne State, then graduated from law school. He practiced law and worked as a legislative aide until his US Congress interlude. He chaired the House Judicial Committee. Conyers did not win all of his political races. He ran for Democratic Speaker of the House twice and tossed his hat into Detroit mayoral races twice. The one cloud in his congressional career was his resignation in 2017, owing to alleged sexual harassment. The Meaning of Wild Famous

Thinker's Notebook

The last days of October are a special time in New York City. Brownstone stoops are decorated with pumpkins and skeletons, and the young children in the neighborhood are ready to trade in their fright for candy. Politicians are making their last rounds, appearing at every church and fall festival hoping to trade in their handshakes for votes. And 50,000 runners (myself included) are ready to trade in an entire summer of training to grab a medal in Central Park on the first Sunday of November.

For the third year in a row, I will be running the NYC Marathon. I've written about the experiences and struggles. I've written about the motivations and the goals. But I wanted to take this chance to introduce you to someone that I consider a b

I met Patrick Burnett in 2010 at Rustik Tavern. We have dozens of friends in common, it was just a matter of time before being in proximity of one another forced us to meet. Pat is calm, measured, he is someone who is friendly but quiet, warm but stoic. I've always known Pat as a runner. He has run over 40 marathons, and he was someone that I looked up to as a runner before we even became close. One time we happened to be in New Orleans at the same time for Essence Fest. I saw him at a party, and with a smile of accomplishment I told him that earlier that morning I had run 4 miles. He smiled, and then replied that earlier that morning he had run 17 miles.

That's Pat. He is a private overachiever, a guy who isn't afraid of the work. It wasn't uncommon at all for me to see Pat running down Bedford Avenue heading to parts unknown to log miles. Early one morning in May 2016, that's exactly where I spotted Pat, on Bedford Avenue headed north while I was heading to the gym. A couple days later, my friend Rudy called me. He

asked, did I hear? Hear what? About Pat. What about Pat? Pat was in the hospital. He was diagnosed with meningitis.

Meningitis is an inflammation of the protective membranes covering the brain and spinal cord. Pat doesn't know how he contracted the illness, but in hindsight, one of the red flags he experienced was severe back pain. After the back pain forced him to spend an entire day in bed, and after a bout of extreme sweating unlike anything he had ever experienced, he went to the hospital. He went at the right time. Had he waited just one more day, Pat may not be

Pat spent 47 days in the hospital. He was unable to walk. The private overachiever was reduced to having nurses help him from the floor after falling on his face while trying to walk to the bathroom. At one point, the doctors told him that because of the lack of progress he might have to live in a nursing home. After proving that he could make it up four steps, the hospital finally sent him home with a wheelchair and a walker. He never removed either from the boxes that they came in. He worked every day to walk again. He used the walls of his apartment as his crutches to get to the bathroom. His girlfriend, Lydia, would come home from work and walk him up and down the stairs in their home. Every day, Pat did a little bit more than the day before. Every day, Pat kept to the challenge, though it seemed at times unfathomable. And finally, in August 2016, three months after contracting meningitis, two months after being unable to walk under his own power, Pat ran a mile. Actually, he ran three. He was going to stop at one, but he got into a rhythm and kept going.

It was at a brunch in Brooklyn, a week or so after Pat ran the Miami Marathon in February of 2017 - his first marathon just 9 months after being struck with meningitis - that he convinced me to run my first marathon. We ran the NYC Marathon together


in 2017. We ran it together last year. And we will be running it together this year.

In 2017, I created a running group called Wild Famous. The idea for the phrase Wild Famous comes from a quote that I read years ago from the Indian Philosopher Jiddu Krishnamurti. He said, "We all want to be famous, and the moment we want to be something we are no longer free." His point was that fame, and the desire for fame conforms and subdues the human spirit. Fame isn't free. It's domesticated like a neutered, declawed pet. Wild Famous is the ideal that being your best self is enough, it says that the greatest freedoms lie in you wanting to be you, not in

Troubled Nonprofit Gets Payout in Flip of Bed-Stuy Landmark to Upscale Developer

Luxury development wasn't what state officials envisioned when they sold an ornate, century-old office building in Bedford-Stuyvesant to an arm of a local anti-poverty nonprofit, seeking to create jobs with "neighborhood-oriented"

focus."

But upscale residences or workspaces are coming to the corner of Throop Avenue and Decatur Street — their way paved by a deputy mayor's removal of a deed restriction that had required the property to remain home to organizations aiding young people.

The nonprofit group — formed to improve Bedford-Stuyvesant when the neighborhood struggled with decay and abandonment — told the state in 2012 that the property would become its new headquarters.

But at a federal bankruptcy judge's behest, sprawling 601-619 Throop Ave. is instead now primed to become a magnet for wealthier newcomers changing the face of the Brooklyn neighborhood.

Voras Enterprise, a nonprofit affiliated with the Northeast Brooklyn Housing Development Corp. (NEBHDCo), sold the formerly state-owned building for \$12 million in June to a firm registered to an outfit called Rivington Company LLC, property, court, business and tax records indicate.

At a March hearing, a representative for the buyer announced a "major construction rehabilitation of this property." In the final bankruptcy plan, approved this month, Voras secured about \$250,000 in charitable donations after settling millions in mortgage, tax and other debts.

NEBHDCo itself is due to get back \$940,000 it poured into running the money-losing, largely empty office building.

Meanwhile, as THE CITY has reported, tenants in some of NEBHDCo's nearly 100 apartment buildings in the area and city housing officials have hauled the group into court to force repairs.

Voras is solely controlled by its president, Jeffrey Dunston, according to IRS records. Dunston, also the longtime CEO of NEBHDCo, reaped nearly \$400,000 in compensation in 2017. One tenant involved in efforts to sell some NEBHDCo apartment buildings to new owners expressed outrage — but not surprise — that the nonprofit moved funds to the Throop Avenue property.

"Someone's got to ask, 'Where were y'all getting this money from without maintaining the buildings y'all already have?" said Dino Perrera, who lives in a NEBHDCo building on Kosciuszko Street.

Moving Out

Court records point to a key role played by a Brooklyn U.S. Bankruptcy Court judge, Nancy Hershey Lord, in expediting the sale over Dunston's objections after Voras filed for bankruptcy in 2017. She rejected Dunston's request to allow his group to hold onto the property after a lender foreclosed, court transcripts show, keen on preserving NEBHDCo's financial health.

Lord then pushed to make sure the state attorney general's office issued a legally required approval and okayed the sale on terms that would usher a major nonprofit tenant out the door — even though the AG had signed off based on documents that said its lease would remain in place.

The Italian Renaissance Revival-style building, part of the Stuyvesant Heights Historic District, sits in an area that today is limited to residential development. The new owner will have the power to convert office space into apartments if they choose.

A tenant on a floor slated for redevel-

opment, Brooklyn Legal Services Corporation A, agreed to take \$400,000 from the new owner to move out of the building, clearing the way for its upscale overhaul, according to a pact submitted as part of the bankruptcy settlement. Corp A, which represents low-income clients in civil matters as well as local nonprofits, also has served as counsel to NEBHDCo's community development programs. Legal Services Corporation A Executive Director Jessica Rose declined to comment.

Jeffrey Dunston did not respond to repeated requests for comment. Nor did Rivington Company CEO Travis Stabler, who has worked on residential projects in SoHo and Brooklyn.

Ghost of Rivington House

The name of the buyer of 600-619 Throop Ave. also evokes the saga of Rivington House on Manhattan's Lower East Side. There, the purchaser of the onetime AIDS residence nudged city bureaucrats in 2015 to lift a deed restriction that had required the building to operate as a nonprofit health facility — and then sold the property for \$116 million. Rivington House sold again last month for \$160 million, Bowery Boogie reported.

THE CITY is unaware of any business relationship between Rivington Company LLC and the sellers of the Lower East Side property.

In the case of 601-619 Throop Ave. built in 1910 as the New York and New Jersey Telephone Exchange Company — officials working for the Bloomberg

administration in November 2012 lifted a decade-old deed restriction that said the building could only be used for "not-for-profit youth development, counseling and educational services."

The city Economic Development Corporation had set those terms in 2001 with a nonprofit associated with then-state Assemblymember Al Vann, once a power broker in the neighborhood, property records indicate.

Deputy Mayor Robert K. Steel and EDC executive Patrick J. O'Sullivan Jr. removed that restriction without putting any new guidelines in place. They did so at the behest of Gov. Andrew Cuomo's Empire State Development Corporation, a state agency, which in 2011 launched a search for a new owner after foreclosing on Vann's group.

The winning project should "maximize job creation," the state noted in its request for proposals: "The foremost theme in the Proposal must be how the proposed plan would benefit the community and bring new jobs onto the Premises."

Empire State Development officials chose NEBHDCo over two other competing groups after allowing one month for initial proposals to be submitted.

The CEO of Empire State Development

at the time, Kenneth Adams, recommended NEBHDCo, materials submitted to ESD's board of directors show. NEBHDCo planned to consolidate its operations there, creating 60 jobs, renovating vacant floors and leasing the second floor to an early childhood education center.

"What gives NEBHDC the edge," Adams' memo to the board said, "is that NEBHDC is from the area, understands the neighborhood and is the best fit for the Property."

A \$3 Million State Mortgage

Dunston formed Voras in July 2012. The entity bought the property that December for \$3.4 million, with the help of a \$3 million state mortgage. Three years later,

foreclosure and other records show, he signed papers refinancing the mortgage — borrowing \$6 million from a lender called Woodbridge Investments. Woodbridge has since been alleged to be a "Ponzi scheme" by the U.S. Securities and Exchange Commission, which has charged company principals with defrauding investors and demanded back \$1 billion.

Voras soon ceased making payments. After a buyer of the debt foreclosed in Brooklyn Supreme Court, Dunston's group filed for precipitating the sale of its

bankruptcy, precipitating the sale of its dreamed-of NEBHDCo HQ.

An Empire State Development spokesperson said in an emailed statement that the state had fulfilled its obligations.

"ESD took control of this property after a non-profit repeatedly defaulted on a nearly quarter-century old loan," said the spokesperson, Jack Sterne. "We immediately issued a competitive request for proposals to recoup the money the state — and taxpayers — were owed, with a focus on selecting a community-based owner with a plan that would benefit the neighborhood.

"At the time, the Voras/NEBHDCo team had strong community support, and we were successful in ensuring more than \$3 million in taxpayer money was repaid to the state. We have not had any connection to the property in over four years."

The state continues to hold a vacant building at 1024 Fulton Street that Dunston had hoped to reboot as a co-living residence for senior citizens.

Decaying Apartments

As THE CITY reported last month, NEBHDCo recently reached a settlement with tenant lawyers and city housing officials to sell 11 Bed-Stuy apartment buildings to new buyers, after the properties

fell into foreclosure and deep disrepair. The dire condition of NEBHDCo buildings gained Dunston a prominent spot on

then-Public Advocate Letitia James' "NYC Landlord Watchlist" last year.

Tenants, many low-income and some formerly homeless, reported extreme difficulties getting maintenance workers to their apartments. City and court records show the Department of Housing Preservation and Development repeatedly sent in crews to do emergency repairs.

Residents described mold, absent heat or hot water, persistent leaks, and rat infestations as issues as far back as 2004. In February, NEBHDCo filed for bankruptcy on 17 of its properties, which had racked up \$4.2 million in debt and more than 4,000 housing violations. Tenants at those buildings are now trying to kick NEBHDCo out. Publicly available records show large sums leaving NEBHDCo and entering Voras without customary documentation.

'Isn't That Problematic?'

Bankruptcy records indicate NEBHD-Co advanced substantial sums to Voras, the entity controlling the Throop Ave. building. In late 2017, NEBHDCo filed a claim with the court seeking \$922,000, without documenting or itemizing the funds owed.

Filings with the Internal Revenue Service dating back to the Throop Avenue property's purchase don't show any sums lent to Voras as an affiliate — transactions nonprofits are asked to report.

Court records indicate NEBHDCo paid nearly \$52,000 in October 2017 to the lawyer representing Voras to file the bankruptcy case, a payment not reflected on NEBHDCo's IRS filings that year. Audits filed with the attorney general's Charities Bureau show loans recorded from NEBHDCo to unspecified affiliates, growing in size over time beginning in 2013. The most recent filing, for 2017, indicates \$907,000 on loan

"Isn't that problematic for that to advance — one not-for-profit to advance to the other?" Judge Lord asked at the first hearing after Voras filed for bankruptcy in November 2017.

"I sure hope not," replied Voras attorney Allen Kadish.

Clergy Take to the Streets

Recently, two groups of young girls had a dispute on the corner of Gates and Marcy Avenues. It was so bad that even when the officers of the 79th Precinct responded to the scene the brawl got worse. Not only did some of the girls get injured, but a few police officers as well. To the point where a patrol of dedicated officers are now encamped on that corner 24/7. This is just one of the "hot spots" in the Bedford-Stuyvesant community.

Accompanied by Community Affairs Officers, the 79th Precinct Clergy Council, a group of motivated pastors from various churches from storefronts

to mainstream made a determination to "go to some of these hot spots and pray." Their mission is to begin the process of reclaiming the neighborhoods for Christ and getting the community to realize that the spiritual leaders are no longer willing to hide behind the walls of their churches any longer and do nothing.

Because of the recent acceleration of criminal activity, which includes shootings, rapes, gang violence and other very dangerous acts, many residents of Bed-Stuy live in fear. The 79th Pct. Clergy Council's President, Pastor Gwen Dingle, insists otherwise, and believes that,

Senator Montgomery and Assembly Member Wright Welcome DFS to Take Deed Theft Complaints In Bedford-Stuyvesant

State Senator Velmanette Montgomery and Assembly member Tremaine Wright will host the first of several intake events for DFS to collect deed fraud complaints on Saturday, November 2nd from 10:30 a.m. - 1:30 p.m. at Restoration Plaza, 1368 Fulton Street in the Multi-Purpose Room, 1st Floor, Brooklyn, NY 11216.

After reading a troubling report on deed fraud and deceptive practices targeted at homeowners in Brooklyn, Governor Cuomo called on the New York State Department of Financial Services (DFS) to launch an investigation. He also directed DFS to dispatch their Foreclosure Relief Unit to assist homeowners who believe they may have been a victim of deed fraud or unfair, deceptive or abusive practices concerning the sale or attempted purchase of their home.

"Predators have been targeting homeowners in our communities for many years and it has only gotten worse as gentrification causes property values to skyrocket all over the city. They target our most vulnerable homeowners and snatch generations of wealth from our families," said State Senator Velmanette Montgomery. "I am glad the governor is directing resources to address deed fraud. I welcome DFS to the 25th District, which includes some of the most impacted neighborhoods in New York State and I encourage my constituents to file their complaints with DFS either in person, over the phone or online."

This announcement comes in the wake of the March legislative hearing hosted by Senator Montgomery, Assembly member Wright and Brooklyn Borough President Adams. Over 300 attendees heard testimony from homeowners, legal experts, foreclosure prevention advocates and stakeholders on homeowner issues including predatory practices and deed fraud. In August, Senator Montgomery's Deed Theft bill was signed into law to address the behavior of fraudulent companies who target struggling homeowners and trick them into signing away their deeds.

"We are disturbed by the recent reports of scammers spinning the American Dream of homeownership to their own benefit," said Superintendent Linda A. Lacewell. "Under the leadership of Governor Cuomo, DFS is investigating and taking action by deploying our team of foreclosure specialists to assist communities who may have been victimized by deed schemes or other deceptive practices. NYPD Officers Aim Gun at Suspect on Crowded Subway, Arrest Him for Fare Evasion

A video of subway riders parting to either side of a subway car as NYPD officers aim a gun at a suspect sitting with his hands up has gone viral with many saying it was a case of abuse of force.

The two-and-a-half-minute video shared Friday shows subway riders in Brooklyn running to either side of the car as an officer draws a gun on a suspect sitting on the subway. As passengers flee to the platform, a group of several officers descends on the man as two handcuff him and others stand on the platform.

Elad Nehorai, who posted the video on Twitter, said that the suspect had shown no indication that he was going to flee or confront the officers. "In case you're wondering how an arrest in NYC goes down, the guy has made absolutely no indication that he would flee or fight and wasn't trying to hide.

If you can't see the reason why everyone moved was because all the police had taken out their guns and aimed at him."

NYPD officials identified the suspect as Adrian Napier, 19. Police said they received a call that Napier seemed to be brandishing a gun near Atlantic and Flatbush Avenues. Napier boarded the southbound 4 train at the Pacific Street subway station as cops chased him. He hopped a turnstile and boarded the train without paying the fare. The arrest occurred when the train stopped at Franklin Avenue.

Napier did not have a gun on him at the time of his arrest.

However, law enforcement said Napier is a member of the Crips street gang and has been arrested 14 times on charges including assault, robbery and grand larceny.

In this arrest, Napier was charged with theft of services for not paying the \$2.75 subway fare when he jumped the turnstile. He was also brought in and questioned because he was wanted in a case of larceny.

The NYPD has been upping its presence in subway stations and cracking down on subway fare evasions for several months. Twitter users pointed out how many officers and how much force was used to take down a man who was not resisting.

They also pointed out the risks of officers drawing a gun on someone while surrounded by innocent people. With the subway door closed at first, if Napier did have a gun, the police aiming at him could have escalated the situation and led him to hold a passenger hostage. Passengers also could have been hit with bullets if they shot.

The NYPD defended its decision by saying that because a credible witness alerted them that Napier had a gun, their use of force was appropriate.

The NYPD said in a statement that Napier was arrested "without incident" for evading the fare and brought in because he was wanted for questioning for a past larceny. It does not mention clearly that Napier did not have a weapon on him.

Another video shared earlier this week showed an unrelated incident at a Brooklyn subway stop where cops punched teenagers while attempting to break up a fight.

Brooklyn Borough President Eric Adams called for the officer seen punching two teenagers to be placed on modified duty and for the department to conduct an immediate investigation into the incident. The NYPD determined that the officer who punched the teen will remain on duty during the investigation. He has called for all NYPD officers to wear body cameras.

Advocates and politicians, including Sen. Julia Salazar and the organization Communities United for Police Reform (CPR), are calling for the NYPD's "use of force" to be scrutinized. Adams also held a "Know Your Rights" session at Borough Hall on Tuesday to educate young community members on what to do when approached by police.

Gov. Andrew Cuomo has ordered the hiring of 500 additional MTA officers to address "quality of life" issues like assaults and fare evasion on subways, but in the wake of this weekend's incidents, activists are demanding more officers not to be brought onto the force.



William Loren Katz: A People's Historian

We are saddened to share that William Loren Katz passed away on October 25, 2019. A memorial will be held in a few months.

For nearly 70 years, William Loren Katz was a teacher and author of people's history books for middle and high school students. Katz wrote 40 books on African American and American Indian history, including Black Indians: A Hidden Heritage and The Lincoln Brigade: A Picture History. His work earned widespread praise from noted scholars including Howard Zinn, John Hope Franklin, Henry Louis Gates Jr., Alice Walker, Betty Shabazz, Ralph Bunche, James M. McPherson, and others.

In the fall of 2014, the Zinn Education Project interviewed William Katz for our series of profiles of historians who document untold history, particularly for young audiences. Katz described his experiences growing up during the Great Depression and teaching during the McCarthy era. He also paid homage to his father Ben Katz, a cultural and political activist.

Childhood

Born in 1927 when Calvin Coolidge was president, I vividly remember the Great Depression. Both my parents had to work, so I was given a key for our apartment. I had an exciting life with many friends on West 13th Street in Manhattan. We played marbles and punch ball and collected war and baseball cards. On my 10th birthday, I got a large bag of cherries and three comic books. Standing in the lunch line at PS 41 in Manhattan, I heard a little girl in front of me tell her friend that her parents gave her a dime on her birthday.

My mother died very early in my life. My stepmother became an editor at Parents magazine; she was very good at editorial work.

One of the most inspiring aspects of Katz's life story is the powerful influence of his father, Ben Katz, on his son's future activism. In the early 1930s, his father was drawn more publicly into politics through his support of New Dealer Fiorello La Guardia's mayoral campaign. Ben's work life also shaped his political views.

My father had a job as a commercial art director for an advertising agency. He hated the work because it amounted to selling people products they didn't need. He started to read on his own, although he dropped out of high school, and then fell

in love with jazz music. He soon had a sizable collection of records including Bessie Smith, Louie Armstrong, and King Oliver. The music forced him to ask more questions about history. My father began asking, "Where did this music come from?" And the answer was that it came from people of African descent who are completely

unmentioned. I was one of the few white kids in the world who was put to sleep listening to music from Bessie Smith and Louie Armstrong and woke up surrounded by books by W. E. B. Du Bois and Frederick Douglass.

When asked how his father's political consciousness developed, Katz explained:

My father grew up in a comfortable neighborhood

in Brooklyn, Bensonhurst, and his father owned a clothing factory. By 1919 he dropped out of high school. There were lots of strikes in 1919, and his father ordered him to run the building elevator when the other workers went on strike. He hated that, he sympathized with the workers. He also saw a lot of factory owners who paid their workers low wages but, as Zionists, contributed money to buy trees to plant in Palestine. He resented the hypocrisy of that.

Katz's early education emphasized obedience to the government and he reflected on the power of those symbols and rituals of patriotism.

At PS 41 the curriculum was patriotic and dull. We read the textbook, as a matter of fact; we read it aloud in class. We recited the Pledge of Allegiance every morning. I remember a time when we sang the Star Spangled Banner; I actually got a tingle in me. I can't explain it, it was psychological, and it made you want to swear your loyalty to the government, ready to do what is asked of you.

Katz's father's political activism acted as a counterbalance to the school curriculum.

My father took me to union meetings and demonstrations. I remember marching in the 1937 May Day parade and I remember signs there, like "Free the Scottsboro Boys!" and signs against Hitler and Muscolini

His father also introduced him to some of the great African American artists of the time.

Before WWII, my father's activism drifted into the areas of defense of civil rights and black self-determination. He became a founding member of the Committee for the Negro in the Arts in the late

> 1940s with such notables as Charles White, Ernest Crichlow, Harry Belafonte, Sidney Poitier, Alice Childress, and so on. He and Walter Christmas co-authored "Lift Every Voice Poetry Production,"

a play on African American history that was performed in the basement of the Schomburg Library.

Growing up during Jim Crow, Katz had the good fortune of living in a desegregated community.

it was a mixed neighborhood, west 13th Street and 8th Avenue, the kids came from all over, they were mixed racially. I remember Harry and Emily were from the West Indies, my good friend Martin Azarian was Armenian, from whom I first learned about the Armenian Holocaust by the Turks that happened around the time of WWI. I also remember our discussions on the street about whether major league baseball should hire black players. I remember some of the silly arguments I heard: "Oh they aren't good enough" or "They are too good." My position was a minority view, which was, of course, they should be allowed to play.

The neighborhood pool was the first place he met the subject of one of his future books, The Lincoln Brigade.

I was 10 years old and it was the summertime. I went to the LeRoy Street public swimming pool and on the other side of the pool I see my father's friend Ernie Crichlow, whom I had met in our apart-

ment many times. He introduced me to his friend, Joe Taylor. When I told my father that I met Ernie and Joe Taylor, he asked, "Do you know who Joe Taylor is?" I said no

He explained that Joe Taylor was one of 90 African Americans who volunteered in the racially integrated Abraham Lincoln Brigade that went to Spain to fight fascism. Joe was a black man and actually he had to swim the Ebro River to escape the Franco forces. When he got to the other side, the Spanish people surrounded him thinking he was one of the Moors Franco conscripted. He explained that he was an American and was rescued. This was the first time I ever met a veteran of the Abraham Lincoln Brigade. Many years later I wrote a book on the Brigade and its 2,800 American volunteers. It was an inspiring example of people coming together across the flaming fires of race to unite against the kind of oppression Hitler was trying to impose on the

High School

In 1941, Katz attended a new experimental high school in Greenwich Village started by progressive educator Elizabeth Irwin, who ran the Little Red School House.

It was there that I was first able to express my knowledge and love of African American history and music. My senior year I wrote a 200-page history of jazz. The first three chapters on slavery were very much like my first book on Black history, Eyewitness. I was in the high school's first graduating class in 1945.

Thanks to his father, Katz's experiences inside this new school mirrored his experiences outside of it.

By then Dad had taken me to the Schomburg Library, and to hear Billie

Holiday, and to jazz concerts at Town Hall he organized to raise money for the integrated United Negro and Allied War Veterans of America. I got to meet my jazz heroes like Sidney Bechet, James P. Johnson, the father of stride piano, and the niece of Bessie Smith named Ruby Walker, in our living room. This had a powerful impact on me.

Later I was introduced to Louis Armstrong and Bunk Johnson, the legendary New Orleans jazzman who helped teach Armstrong the cornet.

In the Navy

Katz served in the U.S. Navy during the last 13 months of the war. He recalls a day's leave he spent in Japan where he saw people begging for money, and how different that image was from the representations of Japanese back in the U.S. Another influential experience was when he got on the wrong side of the captain of his ship, the USS Cook Inlet, who he describes as "a Southerner bigot who drank a lot." The captain didn't like Katz and as a punishment, changed his battle station to the bowels of the ship.

When the alarm went off I raced to my new battle station and found myself sitting with six black sailors I had never seen on the ship before. They were mess mates because that is all the Navy offered black men. We smiled and chatted and talked and joked. We all figured out that the captain wanted to punish me but this wasn't a punishment for me! Quite the opposite. But I had no idea these men were even on the ship. And I thought, "How the hell did I not know?" There were two good reasons: The captain kept them segregated. Secondly, I reasoned, "If I was them at sea, I wouldn't

want to go out on deck."

It was "on deck" where Katz and some other 18-year-old Northern white sailors were surrounded by Southern white shipmates who described horrific lynchings of African Americans.

University Student

As a GI bill student at Syracuse University, Katz collided head-on with the curriculum.

It was dull and useless. The teachers were boring, their knowledge of history traditional and thin. One professor maligned the Molly Maguires as being dangerous thugs and rejoiced at their hanging. He didn't even tell us the story, just that they were horrible people. He made me want to learn more about them, so I wrote a paper. They were oppressed Irish American coal miners who formed a union against Pennsylvania mine owners, only to be framed by the bosses and the state gov-

I had other troubling experiences at Syracuse University, about as far north as you can get. It was 1950 and I was taking a class on the Civil War and Reconstruction. I read W. E. B. Du Bois' Black Reconstruction, and wrote a paper on it that my professor handed back with one word written at the top: NUTS! Now, if you think that is bad, listen to the exam question. We were given five questions to answer, one of him in contact with people who thought

differently. While I was a student at Syracuse University and a Young Progressive I met Woody Guthrie in 1947, and Pete Seeger a couple years later. I met people who shared my interest in history.

Classroom Teacher

After attending the NYU School of Education and receiving his master's degree in 1952, he postponed his teaching career to avoid the height of McCarthy hysteria, the state-sponsored witch hunt for Communists and progressives during the 1950s led by U.S. Senator Joseph McCarthy of Wisconsin. But, he could not resist his calling and began teaching in 1955 at Junior High School 52 in Inwood, Upper Manhattan, despite being forced to sign a loyalty

the U.S. government?" I was called in and asked a couple of questions because I had given two incorrect answers. I found the questions so wordy, convoluted, and confusing that I, in fact, answered yes. The clerks were very nice about it and let me change my answers to those required. They helped me fill it in the proper way (laughing).

Katz describes the way the Board of Education dealt with other loyalty issues.

to question me about my loyalty. I taught briefly in a Jewish parochial school and another teacher reported me for discussing the [Julius and Ethel] Rosenberg case with my class and raising questions about whether they should be executed. I was called into a rather dark room with a long table with me at the one end and three questioners at the other end.

asked me if I was loyal. I said, "What do you mean loyal? I joined the U.S. Navy, I volunteered for WWII. How do I prove it?" One of the interrogators asked, "Do you have any U.S. war bonds?" It just so happened that I owned \$175 in war bonds. Hearing this they said, "OK," and I was off the hook. That was the level of stupidity in the McCarthy era.

His war bonds, rather than the quality of his teaching, secured his job in the eyes

When I began teaching in 1955, I learned to close my door. A teacher in the room above me, a very conservative guy, asked his class, "The president gets \$75,000 a year. Do you think that is too much?" The principal pulled him out of the classroom and told him not to ask questions like that. That was McCarthyism in the public schools.

realize that he wanted to create more accurate and inclusive teaching materials.

In American history classes, African Americans were completely absent, or were portrayed as happy under slavery and bewildered by freedom. I began bootlegging material into the classroom, often eyewitness accounts that revealed the role of black people in American history. It strayed from the curriculum. It challenged textbooks and what they had learned be-

One white parent objected to my using an Abraham Lincoln quote showing his racist thinking. But surprisingly, I found my students, both black and white, liked this content showing how enslaved people resisted and had some white allies were moved by their conscience. Research and Writing

Katz's curricular writing took off while teaching at the integrated Woodlands High School, in Westchester, New York.

It was a new, racially integrated high school and it had been integrated after WWII when white people began moving into the lower-rent black neighborhood. Here I was allowed to develop my materials that grew into my books. I had the wonderful experience of having students evaluate these historical documents and pictures. My first book, Eyewitness: The Negro in American History, was really shaped by my students. I am still in touch with some of them.

Katz also recognizes the scholars and activists that helped supply him leads, documents, and photographs.

These people included: Ernest Kaiser, one of the librarians at the Schomburg Library, had an encyclopedic knowledge of African American history; Jean Blackwell Hutson, the director of the Schomburg; Dorothy Burnett Porter of the Moorland-Spingarn Research Center at Howard University; and Sara Dunlap Jackson of the National Archives.

These unsung black historians and archivists were the ones who were promoting this material. I was guided by the pioneering research of W. E. B. Du Bois, and met and became friends with John Hope Frank-

I also stumbled on a white researcher, Kenneth Wiggins Porter at the University of Oregon, who was writing on African Americans in the West from the time of Herbert Hoover's administration.

I met editors Esther Jackson and Jean Carey Bond of Freedomways, a journal of the Black Liberation Movement and began to write articles for them in 1970. By this time Howard Zinn was taking people's history to the public.

Asked to name his favorite book, he turned to the subject of Black Indians.

A number of my books like Eyewitness and The Black West caused quite a stir, but nothing like Black Indians. People called me at night, wrote letters, sent me photos, called in to radio programs to ask questions, people stopped me on the street.

The book has not been reviewed in any major publications, but was sold by local street vendors in the major cities. Yet I was being invited to address the National Alliance of Native Americans and made an honorary member. An Ohio Black Indian organization gave me an award for bringing people of color together. American Indian Studies and African American Studies departments at colleges were asking me to speak, and I was interviewed on African American and American Indian radio and TV programs.

> Katz concluded with words of advice for people who are debating whether to become a history teacher in the face of the countless challenges facing the profession.

They should follow their courage and go ahead. I don't know if I can offer relevant advice since I had to bootleg material into my classroom. Now HYPERLINK "http://howardzinn.org/"Howard Zinn's books are out there and have broken barriers. Zinn proved that this kind of history can't be ignored. People have to stick to their principles. I have always maintained that the school curriculum has been an important obstacle to progress in public policy. It has misled people about what our history has been and who has made it. We need educator activists to keep doing what they are doing.
